The Kings County Elections Department is anticipating an exciting 2020 Presidential Election Cycle. The Dates for the Presidential Election will be **Tuesday March 3, 2020** and **Tuesday November 3, 2020**. We anticipate the need for more poll workers, so we would like to get interested voters added to our election worker list.

- The polls will be open from 7:00 AM to 8:00 PM.
- Poll workers typically work 6:00 AM to 9:00 PM.
- Inspectors are paid \$140.00 per day & Clerks: \$110.00 per day
- Attend mandatory training class
- Must be able to read and write English
- Ability to fluently speak, read, and write Spanish is desired
- Basic computer skills are helpful
- Must be willing to work 14-15 hours on Election Day
- Excellent interpersonal skills in order to interact and cooperate with co-workers and to deal effectively with voters, poll watchers, electioneers, and the general public
- Ability to read, comprehend, and follow Laws and directions given by the Kings County Elections Department.
- Occasionally lifting and carrying objects weighing up to 50 lbs., such as election equipment, ballots, supply boxes, etc.
- Ability to recognize election issues and to promptly report any issues to the Election Office as necessary
